Fees should be paid within 30 days of the invoice date and before the start of a course.

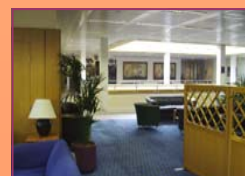
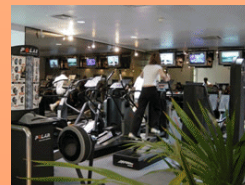


## EXTRA ACCOMMODATION
